#### Tasks:

- Perform a screening examination using established guidelines to determine if and when treatment is indicated.
- Gather pertinent records to properly diagnose the nature of orthodontic and dentofacial problems and their etiologies.
- Develop a comprehensive diagnosis based on the patient's chief treatment planning.

#### **Domain 4: Critical Analysis/Outcomes Assessment**

- Assess dental, periodontal, and neuromuscular health using appropriate guidelines.
- Evaluate post-treatment occlusion using accepted standards asses the overall efficacy of treatment.
- Evaluate treatment outcomes comparing pre-treatment and posttreatment records to assess dental and skeletal changes.
